2) How do I join the meeting or session(s)?

- a. Simply click on the provided link located above within the agenda (Zoom Link #) and enter the passcode provided for each session (if prompted for passcode).
- b. Each session will have its own unique link, so be sure to access the appropriate link depending on the session.
- c. It is highly suggested to download the Zoom desktop client or mobile application ahead of the meeting to join.
- 3) Overview of the attendee control bar (bottom of screen):



a. Entering/Leaving the meeting:

- i. Click on the proper link to enter the Zoom meeting room.
- ii. Click on the "Leave" button at the bottom right-hand corner to exit the session at any time.

b. Sound/Video Recommendations

- i. It is recommended to be in a quiet environment with quality connectivity for best results.
- ii. Headphones may make the sound quality a better experience overall.
- iii. Video: any standard built in, or external webcam/mobile camera should be recognized by Zoom and can be selected by clicking the ^ arrow next to the video icon.
- iv. Audio: any standard built in, or external microphone/mobile mic should be recognized by Zoom and can be selected by clicking the ^ arrow next to the microphone icon.

c. Mute/Unmute

i. Mute and unmute your microphone (single click the icon)





d. Stop Video/Start Video

- i. Turn on and off your video (by clicking the icon)
- ii. It is recommended to keep your video off during presentations to maximize your connection stability.



- I am interested in serving on the executive committee to benefit the members and supporting organizations of District IV. I think the opportunity to learn from the current board members and share my leadership experiences would be another way for me to serve the pharmacy profession that I have been a part of for the last 25 years.
- I hope to elevate the district by building on the current relationships I have in pharmacy and expanding those throughout the district and country. I think I can help expand the awareness of the organization in the pharmacy community and help pharmacist become more aware of the organization and its goal of promoting the practice.



O I have had the opportunity to work closely with Purdue University and pharmacy students for the last 25 years of my career. I have recruited, developed, and mentored hundreds of pharmacy students as they have gone on to pharmacy careers. The relationships with students and pharmacists over this time frame allow me to understand the current challenges pharmacists are facing in their early, mid, and late time in their careers.

25 years since graduating in 1996, I never imagined I would have been immunizing, owning an independent pharmacy and have a seat as the Vice Chair of the Michigan Pharmacy Board. The practice of Pharmacy needs to go beyond the count, lick and stick perception. As we near provider status, more work will be necessary, including how to navigate the reimbursement for pharmacy clinical services. I am ready for that call and will continue to pave the road to expand the pharmacy scope of practice.



- My first impact on the practice of Pharmacy in Michigan was during the 2009-2010 H1N1 pandemic. Being ahead of the curve and partnering with Pharmacy Students, we were able to administer over two thousand H1N1 Nasal Vaccines in less than 2 weeks. Since opening my own pharmacy I have learned how people view the pharmacy world. I have witnessed, experienced, and understood firsthand how to keep the needle moving forward and this is the next step to practicing pharmacy beyond the pill.
- I was able to navigate with the PBM's, Health Department, and other Health Care Providers to become one of the first pharmacies to get an insurance contract for proper reimbursement for administration of the H1N1 vaccine. I have learned how to explain and bridge the gap to those who need to learn about how capable and necessary pharmacist are in today evolving healthcare setting.
